TERMS AND CONDITIONS

All credit sales made by Columbia Grain International, LLC (CGI) and its successors and assigns to Applicant are due and payable in full according to the terms of sale specified on the invoice. No terms or conditions of sale different from CGI's terms of sale will become part of any agreement unless approved in writing. A finance charge at the rate of 18% APR (Annual Percentage Rate) or the highest amount permitted by law, will be assessed against sales, which have not been paid within 30 days of the date of the statement. Said interest will be assessed on the 30th day following the statement date. Applicant agrees that all other terms and conditions of sales shall be governed by the invoice, which may be sent to Applicant after product is delivered. If Applicant's account incurs finance charges, Applicant agrees that any subsequent payment received or credits may be applied first to past due finance charges and second to outstanding invoice balances at the sole discretion of CGI. CGI has the right to reduce the Applicant's credit limit and/or withdraw Applicant's credit under this credit agreement at any time and without prior notice, except as otherwise required by law. CGI reserves the right to revoke credit, demand full payment, or an adequate additional security instrument if Applicant fails to pay when due, or if in the sole discretion of CGI, there has been an adverse change in the financial standing of the Applicant and/or guarantor. Default by Applicant under the terms of this Agreement or any agreement between Applicant and CGI shall be a default under all other agreements between CGI and Applicant. CGI does not waive its rights by accepting late payments. If provisions contained in this credit Agreement is determined by a court to be in conflict with applicable law, that provision shall be considered changed or omitted to conform to such law, all other provisions of this Credit Agreement shall remain in full effect. Nothing in this agreement is deemed to limit CGI's collection rights or remedies. Applicant agrees to pay reasonable attorney fees and cost of collection. We are not bound by any notation of « paid in full » that accompanies any payment if such payment is not for the total outstanding balance. We are authorized to file an agricultural lien as allowable by state law. Applicant agrees that CGI may offset and apply any amounts it may from time to time owe the Applicant for whatever reason against any unpaid past due balance of the Applicant. Until notified in writing to the contrary by the Applicant, CGI may assume that the Applicant's spouse, children over the age of sixteen and employees, are authorized to purchase goods and charge them to the Applicant's account.
